SECTION 1 - WHAT DO WE DO WITH YOUR INFORMATION?

We use Populi, RegFox, and Ecwid to provide us with the online e-commerce platform that allows us to sell our products and services to you.

Payment:

Payments are processed through the Authorize.net payment gateway. All direct payment gateways adhere to the standards set by PCI-DSS as managed by the PCI Security Standards Council, which is a joint effort of brands like Visa, MasterCard, American Express and Discover.

PCI-DSS requirements help ensure the secure handling of credit card information by our store and its service providers.
